**WHEREAS**, the Town of Danby Planning Board through its ongoing Comprehensive Planning process is charged by the Town Board with managing and implementing the Comprehensive Plan; and

**WHEREAS**, the Town Board Resolution of December 14, 2009 requesting GOVERNOR DAVID A.
